The Westchester Golf Association Caddie Scholarship Fund, a 501(c)(3) charitable and educational nonprofit corporation under the IRS Code, provides need based financial assistance to qualified caddies and others who work in service to golf, aiding the pursuit of higher education.

Turnesa, an honorary member of Knollwood Country Club and Quaker Ridge Golf Club, and longtime friend, Udo Reinach, a member of Quaker Ridge Golf Club, founded the Reinach-Turnesa Scholarship Fund in 1956, now the Westchester Golf Association Caddie Scholarship Fund. Awards have been made to 1,975 deserving young men and women who have received over \$9,000,000 in scholarship awards.

## Current Scholarship Recipients

In the 2008/2009 school year, 269 students are receiving financial aid from the WGA CSF. These students represent sixty-one Westchester Golf Association member clubs, and attend 153 colleges, universities and trade schools.

To be eligible, the applicant must have served a minimum of two seasons as a caddie or in service to golf at a club that is a member of the WGA. He or she also must be recommended by the club, require financial assistance to attend college, and possess an adequate scholastic record. Club members and their children are not eligible to apply.
